### Situation Overview

The first twelve days of April were focused on developing a better inventory database and logistical mechanism. Our priority is filling in the gaps in essential aid for unaccompanied minors whilst addressing emerging needs within the system of service provision for 20,000 people living in Moria. Throughout this process we are making sure that Better Days is able to fill the requests coming from several partners simultaneously whilst successfully juggling amongst several fronts. For example, while our Lesvos-based team has been putting most of its efforts in logistics and procurement support for medical actors and RIC, our Athens-based team has been monitoring, participating, drafting and contributing to the relocation efforts and calls for action aiming in policy-change and immediate action to decompress the islands of the Aegean. Our determination is fuelled by the first hand testimonies the minors have been sharing with us, regarding the worsening conditions in Moria camp and fears about their ability to remain safe and healthy in the aftermath of an outbreak of covid19 in the camp.



#### **ATHENS**

The team has been working on 69 family reunification cases in order to ensure that their reunification process remains open and active. Coordination of the process between the children, the relatives, our team in Moria and the DCI lawvers about the DNA tests. the gathering of information and documents to support the reunification claim, the drafting of the BIAs and so forth. Beside that there is now daily contact with the minors which aims in providing emotional support, critical information and accompanying them through these really difficult times. It is vital for the children to know what is their situation, to give them information that they can trust and to stay in touch with them to let them know they are not alone or forgotten. In Athens, our collaboration with DCI is about to expand in providing group sessions (esafe spaces) to UASC living in Youth centres. This pilot program is about to start in wk3 of April.

#### **LESVOS**

procuring and distributing Focus on essential NFIs & critical PPE to partner organisations working in the camp and directly to the UASC Sections and RIC. In the past two weeks we have been putting a huge amount of work in procurement locally and nationally, in search medication, wound care products, hygiene items, PPE: gloves, disinfectant gels, soap and masks, as well as washing powder and multivitamins for the sections. Together with Attika Human Support we were able to prepare 125 clothing packs for the UASC run living in Moria. We now community houses. Two MSF-community will volunteers be movina in Community House 2 in Panayiouda. Community House 1 in Chrysomalousa is hosting 5 people. The HPF clinic for unaccompanied minors has been relying on the constant supply of clothing kits to deal with another scabies outbreak which affected most of the kids. We has responded to Eurorelief's urgent request for rubbish bags and toilet paper for the sections and RIC's outcry for vital PPE for their operating staff.
